The Organizing Authority is the Italian Sailing Federation (FIV) which delegates its organization to the affiliate Univela Sailing s.s.d.a r.l. in conjunction with the Italian A-Class

1. RULES:

- 1.1 The regatta will be governed by the rules as defined in The Racing Rules of Sailing (RRS) and the IACA.
- 1.2 The sailing instructions may consist of contain minor changes to the RRS.
- 1.3 If there is a conflict between languages the English text will take precedence.
- 1.4 In case of difference between NOR and Sailing Instruction (SI) the SI will prevail this changes RRS 63.5.

4 ELIGIBILITY AND ENTRY

- 4.1 The regatta is open to all A-Division Catamaran Class certified boats.
- 4.2 Competitors must be registered at their National Class for the year 2026.
- 4.3 Competitors shall present upon registration:
 - a) Italian sailors shall show their FIV membership card 2026 with valid medical certificate.
 - b) Foreigner sailors shall carry the membership card issued by their national authority.





5 ENTRY FEES:

5.1 The registrations shall be made on the following website <https://www.campioneunivela.it/regate/2026/a-cat-trofeo-univela/>

5.2 The entry fee is € 150,00 and is to be paid by Credit Card by 20 september 2026. Any later entry will be subject to the additional entry fees of € 50,00. The entry fee includes the free social dinner at Univela restaurant that will be on Friday 2 October at 19:00.

5.3 The registration shall be displayed at the Entry List only when the Entry Form with all information filled in and the payment of the non-refundable entry fee shall be sent successfully. The successful payment will be considered a confirmation of entry.

6 ADVERTISING

6.1 Boats may be required to display the advertising chosen and supplied by the organizing authority.

6.2 Advertising is permitted as per the Class Rules according to WS Regulation 20

6.3 Italian boat displaying advertisements must submit the FIV licence.

7 SCHEDULE

7.2 Without notice on the notice board, the warning signal time will be the same as the day before.

7.3 On the last day of the regatta there will be no warning signal after 16:30 hrs.

10 PENALTY SYSTEM

10.1 Rule 44.2 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.

10.2 A boat that has retired according to RRS 44.1 and 44.2 shall communicate the same to the secretary office via email at info@univela.org within the protest time limit. If not, the penalty shall not be considered



10.3 Any boat that retires after finishing shall communicate the same to the secretary office via email at info@univela.org before the end of the protest time limit.

11. SCORING

11.1 The Low Point scoring system of RRS Appendix A will apply

11.2 A total number of nine (9) races are scheduled.

11.3 No more than three races may be sailed per day.

11.4 The event will be valid even with only one valid race.

11.5 When fewer than four races have been completed, a boat's series score will be the total of her race scores.

11.6 When from four to six races have been completed, a boat's series score will be the total of her race scores excluding the worst score. When seven to nine races have been completed a boat's series score will be the total of her race scores excluding the two worst score.

12 SUPPORT BOATS

12.1 All support boats shall be registered with the Organizing Authority and will be required to comply with local legislation and event support boat regulations. The Organizing Authority may refuse registrations and accept later registrations at their sole discretion.

12.2 The registrant of a support boat will be charged for a not refundable fee of € 50. The fee includes crane use (first and last day), trailer parking and berthing in the harbour.

12.3 Support boats with team leaders, coaches and other support personnel shall stay outside areas where boats are racing from the time of the starting sequence until all boats have finished, or the race committee signals a postponement, general recall or abandonment. Support boats shall comply with any reasonable request from the regatta officials.

13 DISCLAIMER OF LIABILITY

13.1 RRS 3 states: "The responsibility for a boat's decision to participate in a race or to remain in the race rests solely with her." Therefore: By participating in this event every competitor agrees and recognizes that sailing is a potentially dangerous activity that carries risks. These risks include the possibility of dealing with strong winds and rough seas, sudden changes in the weather, breakdowns / damage to equipment, mishandling of the boat, poor seafaring by other boats, loss of balance due to vehicle instability and fatigue with resulting in an increased risk of injury. The risk of permanent and serious injuries or death by drowning, trauma, hypothermia or other causes is inherent in the sport of sailing.

13.2 A competitor shall maintain his boat in a safe and seaworthy condition.

14 SAFETY

14.1 By signing the entry fee, competitors shall comply with the following:

- Put safety of yourself and competitors above race results.
- Keep the boat park and sailing area clean of any debris.
- Do not leave the boat park without the necessary safety precaution.

14.2 A boat that retires from a race shall inform the race committee as soon as possible and before leaving the race area and communicate the same to the secretary office via email at info@univela.org

14.3 Boats not leaving the harbour or beach for a day's race shall inform the race office prior to the start.

14.4 For vessels equipped with J or Z-boards, the helmsman must wear a safety helmet at all times while racing.



15 ENVIRONMENTAL RESPONSABILITY

15.1 Recalling the Basic Principle that mentions: "Participants are encouraged to minimize any negative environmental impact of the sport of sailing", we recommend the utmost attention to environmental protection in all moments that accompany the practice of the sport of sailing before, during and after the event. In particular, attention is drawn to RRS 47 - Waste Disposal - which verbatim states: "Competitors and support people must not deliberately throw waste into the water. This rule always applies when in the water. The penalty for infringing this rule can be less than disqualification".

16 INSURANCE

16.1 Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of Euro 1.500.000 per incident or the equivalent in currency.

16.2 Proof of insurance shall be provided on registration.

16.3 Any competitor under 18 years old will be required to obtain parental/guardian written consent.

17 PRIZES

17.1 The following prizes will be awarded for A-CAT sailors:

- Prizes will be awarded to the first 3 classified of each category with more than 3 competitors in it..

18 RADIO COMMUNICATION

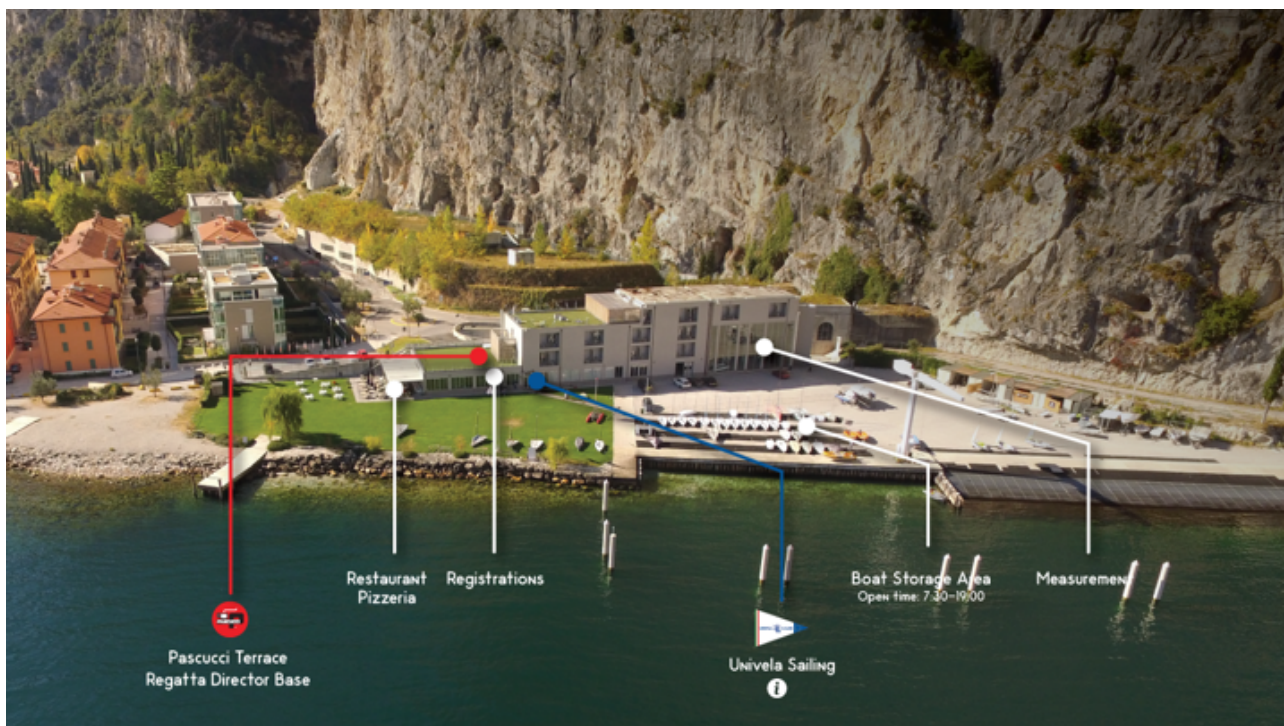
18.1 No equipment capable of radio transmissions or radio communications may be carried by any competitor while on the water. This restriction also applies to mobile telephones and other electronics devices.

19 PHOTOGRAPHY CONSENT

19.1 By entering the Championship competitors accept that they may be photographed and/or videotaped participating in the race and/or using the regatta facilities and they consent to the taking of such images and to the use, re-use, publication and republication of such images in any media, in conjunction with the competitor's name or not, without compensation and without the competitor's approval of such images or any use thereof.

20 TRAILER PARKING, DOCKING AND CARS

20.1 All participants shall park their boats and road-trailers on the premises of the harbour Regatta Centre. Cars shall be parked in the designated parking areas. No cars are allowed at the dinghy park. Please follow the harbour master's instructions.



21 ACCOMODATION
